The office will be co-located with Yaskawa Elétrico do Brasil, the Brazilian subsidiary of Yaskawa America, Inc. that was established in 1974. This subsidiary brings experience and knowledge of the Brazilian manufacturing and sales processes. Yaskawa – Solectria Solar Brazil offers its commercial and utility-scale products and solutions to meet the demands of these solar markets in Latin America.

“[Yaskawa – Solectria Solar](#) has seen large growth in the PV industry and its customers in Latin America and expects this growth to continue. The LATAM market as a whole is expected to grow more than 75% over the next 5 years.
